IMPORTED WASTE PAPER AND ITS PRICE COMPARISON IN INDIA

Abstract:

The Indian paper industry is a booming industry and is expected to grow in the years to come. The usage of paper cannot be ignored and this awareness is bound to bring about changes in the paper industry for the better. Application of paper is varied and one cannot think of a life without paper.

INTRODUCTION

The Indian paper industry has made steady progress since independence and is ranked among 15 global paper industries. Non availability of good quality of fibrous raw material is one of a challenge the industry is facing in the current scenario.Non availability of good quality fibrous raw material is a big challenge for Indian paper industry to cope up with the escalating demand. In totality, India imports nearly 450000 tons of pulp, 25,000 tons of recycled paper and about 8000 tons of finished paper annually.

It has been visualized that the demand for paper in the country shall be round 15 million metric tons by the year 2012 and by 2025, it would be close to 2.5 metric tons which is not an easy task to meet because of regular decrease of it conventional fibrous raw-material.

POLICY OPTIONS

Based on the foregoing discussions, the following policy options can be examined for improving the collection and recycling of post consumer paper in India:

1. The government could formulate a policy on management of waste paper in line with the e-Waste (Management and Handling) Rules 2011 as formulated by Ministry of Environment and Forests. This policy will lay down the guidelines and procedures for the producers, collection centers, dismantlers and the recyclers.

2. The government could simultaneously announce a scheme to provide incentives to municipalities to meet source segregation targets by making it obligatory for households to segregate the wastes and impose a fee on commercial users. Alternatively, a fee structure for waste collection may be proposed along the lines of the German model.

3. Guidelines for allocation of land on lease for development of sorting centers/ warehouses for sorting,

baling and storage of waste paper could be developed by the Ministry of Urban Development. These sorting centers / warehouses may be developed through the PPP route by bidding system so that collected, sorted & baled waste paper is directly sent to recycling units.

4. Regulations may be formulated mandating use of shredders by all offices and collection of shredded waste paper through contract agreements on annual basis.

5. Voluntary guidelines to contribute to waste paper collection efforts under CSR could be put in place by industry and chambers of commerce to encourage private sector participation.

Strategies required to achieve envisaged growth for waste paper

Recycled/Waste paper

Setting up of RCF/Waste paper collection centers
Possibility of imposition of legislations
Awareness creation
Strengthening the capability of CPPRI for conducting R&D activities and Pilot plant trials
Modernization of entire RCF/WP based industry by way of adopting state-of-the art technology to manufacture
Newsprint & packaging grades of paper.







RECOMMENDATION ON PULP & PAPER INDUSTRY

Recycled Fibre (RCF)/Waste paper

•There is a need to intensify the collection of Indigenous Waste Paper to increase the present recovery rate from 27% to 50%. It is proposed that Municipalities may work together in association with private operators/industry based on a workable model. For financial support, a performance-based mechanism should be considered.

•Awareness programmes may be organized to sensitize the public at large. The concept of paper recycling may be promoted using the print and electronic media throughout the country.

•Eco-labeling of recycled paper products should also be promoted.

•Efforts are required to enhance quality of recycled end products by strengthening the capability of CPPRI for conducting R&D activities and Pilot plant trials. At present, CPPRI does not have adequate R&D infrastructure & pilot plant facilities for processing of recycled fiber. It is therefore recommended that during 12th Five Year Plan, adequate funds may be allocated to CPPRI for creation of Center of Excellence on paper recycling inclusive of R&D infrastructure & pilot plant facilities.

CONCLUSION

(1)The paper industries should adopt "Reduce-Reuse-Recycle" philosophy in all operations and should

increase the scope of this philosophy beyond the boundaries of their factories

(2)Major waste paper used in recycling is Old Corrugated Containers which accounts to 40%. The first and foremost requirement for long term sustainability & growth of RCF/WP based industry is to meet the waste paper requirement indigenously by reducing the burden of imports of waste paper and improving the quality of finished products i.e. newsprint and packaging grades (Duplex & kraft).

(3)Today there is a complete lack of an effective collection mechanism which could automatically divert RCF/ waste paper to the paper industry.

(4)Policies on import should be conducive for import of waste paper. Therefore, duty free import of paper may be allowed till indigenous capabilities are developed

(5)The cost of raw material (waste paper) and fuel in India are very high while overseas competitors have access to captive plantations and cheaper fuels. Even if fiber is imported, the cost for domestic producers is higher vis-à-vis their overseas competitors. Till such time as the proposed model for availability of raw material through reforestation of degraded forest land is realised, the industry should get protection in the form of higher customs duty on import of paper.

(6)The risk of international shortage/price peaks of waste paper due to increasing recycling levelsin North America and Western Europe, and the increasing dependence of Asia-Pacific and Latin America paper industries on offshore waste paper supply.

(7)The cost of imported waste paper can be brought down by following measures:-

·Global sourcing (Europe, North America, Gulf countries)

·Long term contacts with international merchants/exporters

·Mill location close to main ports

·Backhaul opportunities to lower transport costs

·Allow duty free imports

(8)Sorting and deinking of imported waste paper could be one option to enhances the value of the fibre

In India mills depending upon waste paper for recycling are facing a shortage of raw material while the demand is growing as the mills are expanding. This is driving up the cost of waste paper which has gone up to around Rs 10 a kg, almost double of what it used to cost a year ago.

In a recent report, Central Pulp & Paper Research Institute (CPPRI) has stated that by 2010 about half of the global amount of fibers used in papermaking will be recycled fibers. However the report admits that recycled fibre sourcing in India is a challenge. Import of waste paper has increased significantly during 1995-2003 onwards since Industry�s dependence is increasing on imported RCP due to inconsistent supply of indigenous RCP and the recovery of indigenous RCP being low due to unorganized collection system IPMA feels paper recycling, in the overall contest of waste management, needs to be looked at as an enterprise.
