### INTRODUCTION-

### **REVIEWS:**

Scanlan (J Allied Health 2006;35(3):179-85) observed that student academic misconduct has become a growing problem for colleges and universities, including those responsible for preparing health professionals. Although the implementation of honour codes has had a positive impact on this problem, further reduction in student cheating and plagiarism can be achieved only via a comprehensive strategy that promotes an institutional culture of academic integrity. Such a strategy must combine efforts both to deter and detect academic misconduct, along with fair but rigorous application of sanctions against such behaviours. Methods useful in preventing or deterring dishonest behaviours among students include early integrity training complemented with course-level reinforcement, faculty role-modelling, and the application of selected testing/assignment preventive strategies, including honour pledges and honesty declarations. Giving students more responsibility for oversight of academic integrity also may help address this problem and better promote the culture needed to uphold its principles.

### WHEN DO WE CALLA PUBLICATION PLAGIARISED?

In any institution or committee they are specialists who check manuscripts or articles for plagiarism. The material then is only said to be plagiarised when the author has not cited his primary or secondary sources, nor has he acknowledged the references or the works of other eminent authors during his writing. Thus one must bear in mind not to involve in plagiarising any material which is not of one's own original work and must be careful not to publish the same article in different journals.

### WHY ONE SHOULD NOT INDULGE IN PLAGIARISM?

Plagiarism is a threat to the academia and research fraternity. Thus such practices should not be indulged as this result towards violation of ethical code of conduct. As an educationist, we must endeavour to bring awareness about the consequences to those who indulge shamelessly in such acts, as this brings a bad reputation of the individual, organization and committee.

Authors who want to publish their manuscripts must make sure they are aware of the guidelines in order to comply to protocols before they can send their articles for submission, failure to do so can lead to rejection and hence they can be snatched the legal authority and opportunity to further submit their articles to any publication.
