- **7.Social Legislation:** The joint family system has received a great setback from several legislations. These legislations are:
- The Hindu Law of Inheritance, 1929
- Hindu Women Right's to Property Act, 1937
- Special Marriage Act, 1954
- Hindu Marriage Act, 1955
- Hindu Succession Act, 1956

Dowry Restraint Act, 1961These Acts have not only modified the inter-personal relations and the composition of family but also the stability of joint family. The Hindu succession Act, 1956 has brought about fundamental changes in the Hindu joint family structure by conferring equal rights on women in inheritance. Special Marriage Act, 1954 has permitted the freedom of mate selection and marriage in any caste and religion without the parent's consent. This has affected the marriage system to a large extent.

- **8. Population Increases:** Populace increases have brought on inordinate weight on the agrarian and private land. The agribusiness no longer gives work to the steadily expanding number of individuals relying upon it. Poor people and the unemployed abandon their homes looking for work somewhere else.
- **9.Education/Literature:** Education/Literacy has influenced joint family framework in more routes than one. It has achieved changes in states of mind, convictions, qualities and belief systems of the general population. These progressions are noticeable among both guys and females who are instructed. Training has likewise made individualistic demeanors among the informed people. Consequently, instruction has conflicted with the upkeep of the joint family framework.

- 11.Decline in Village Industries and Agriculture: The joint family framework developed as a result of agrarian culture.
