#### What is criminology?

The scientific investigation of the nature, degree, causes, and control of criminal conduct in both the individual and in the public eye is called criminology.

#### **Components of wrongdoing:**

#### Phases of perpetrating a wrongdoing:

#### The commission of wrongdoing includes four phases:

- + Intention: For the commission of wrongdoing, the first critical stage is criminal expectation. Be that as it may, simply having a criminal goal is not culpable until it is passed on to another person in words or by acts. Case: An aim to execute somebody.
- + Groundwork: To carry out a wrongdoing, earlier arrangement is important if the wrongdoing is

deliberate. It is difficult for the court to rebuff an individual simply in light of a readiness arrange until and unless it is executed. For instance, kill, dacoity, and so on.

- + Preliminary wrongdoing: An endeavor to carry out a wrongdoing is considered as preparatory wrongdoing. An endeavor ought to incorporate a criminal aim, a demonstration towards carrying out a wrongdoing what's more, a demonstration of wrongdoing which is not totally refined. Illustration: Attempt to kill
- + Completion of wrongdoing: This is the last stage in commission of wrongdoing. The criminal finishes the wrongdoing. A suspect is blameworthy of an offense just in the event that he prevails in his criminal movement. Illustration: Successful achievement of murder
- + Causes of wrongdoing : No individual is a conceived criminal, it is the circumstances and the conditions around the person which make him go about as a criminal. There are a few causes which make an individual transform into a criminal. The primary driver of wrongdoing are:
- a. Social causes
- b. Financial causes
- c. Mental causes
- d. Oranic causes
- e. Land causes

#### SOCIAL REASONS FOR WRONGDOING:

#### The social reasons for wrongdoing incorporate the accompanying:

**i.Family disorder:** Family assumes the most essential part in an individual's life. In long time past days, there were joint families and there was dependably a family control on the kids.
