- Access time depends upon network performance.
- Connection failure may cause serious problem
- Noise/Disruption in telecommunication lines can cause serious problems.
- It required expertise knowledge of the use of computer and allied devices
- Universally there is no uniformity for indexing
- Poor quality of data a lot of without proper organization and structure.
- •Inadequacy of awareness although usage of online services in the context of libraries is growing, online services reach only to a fraction of the total population
- The telecommunication infrastrture is such that access internet is slow.
- The older generation is unaware of the latest facilities that are available
- •Limited access participates in online services do not represent the entire community
- There is sizeable number of persons who are not comfortable with the modern technologies.
- Lack of Reliability online services must be used in conjunction with other techniques that allow user to get information guickly. Authenticity of the information posses a serious problem.
